



STATEMENT OF CONSENT FOR THE PERSONAL DATA PROCESSING

APIOS d.o.o., as the Data Controller, hereby informs you that your personal data were sent from the web site www.apios.hr (hereinafter referred to as: the web site) and that such data will be processed.

By accepting this Statement, it is hereby considered you are providing this consent freely and specifically for collecting and further processing of your personal data given to APIOS d.o.o. as the user through the web site for the purposes herein expressly indicated. The data are given freely, and therefore you are under no obligation to accept this Statement, i.e. you are not obliged to enter your personal data to the LOYALTY membership Application Form, available on this web page.

By accepting this Statement and providing your personal data by entering them in the LOYALTY membership Application Form, it is hereby considered that you are compliant with the processing of such data. The provided personal data will be processed for the purpose of issuing APIOS LOYALTY cards with benefits, purpose of administration and managing services, marketing purposes (delivery of information, offers and advertising material about the products and/or services of APIOS d.o.o., improving APIOS d.o.o.'s advertising and market research).

Your processed data shall be kept for a period of 10 (ten) years, after which these data will automatically be deleted, pursuant to procedures prescribed by the company's GDPR Policy.

You are entitled to oppose to personal data processing for the mentioned purposes at any time and you may withdraw the consent given.

APIOS d.o.o. shall treat your personal data pursuant to the Personal Data Protection Act, i.e. the General Data Protection Regulation (GDPR), by applying appropriate physical and technical security measures of personal data protection from unauthorised access, misuse, disclosure, loss or destruction.

The procedures and treatment of personal data, as well as physical and technical-security measures of personal data protection are prescribed pursuant to the requirements from the GDPR regulation, through the Information Security Policy of the company, internal Bylaws and the company's GDPR Policy.

APIOS d.o.o. respects and protects privacy of its users and web site visitors, keeps confidentiality of your personal data and disables access and disclosure of your personal data to any third party, other than its employees and company's data processors, who require such data for the purpose of conducting their business activities related to the nature of the business they perform. Your personal data may not be disclosed to third parties without your previous specific consent, except for and only in cases prescribed by the law.

The Data Controller of your personal data is a registered office APIOS d.o.o., at the address Budmanijeva 5, Zagreb.

You may at any time obtain access your personal data that are being processed, and request them to be rectified, amended or supplemented.

You are entitled to withdraw/revoke the consent given to data processing at any time, either in whole or partially, without any fee or explanation required, i.e. you can call off such a consent and request termination of processing activities regarding your personal data and marketing activities directed towards you.
